It was established under the Health Professions Act No. 24 of 2009.

The mission of the Health Professions Council of Zambia is 'to safeguard the quality of healthcare services by regulating and monitoring the professional conduct of Health practitioners, Health facilities and Training Institutions offering HPCZ approved training programmes. HPCZ seeks applications from suitably qualified and experienced persons for the following position:

1. REGISTRAR / CHIEF EXECUTIVE OFFICER

Job Profile: To Oversee the Registration of health practitioners, the Licensing of health care facilities, the Accreditation of health services and the Approval of health related training programmes in order to assure the provision of quality health services and any other duties as assigned by the Council.

Main duties:

- Oversees effectively the registration and issuance of annual practicing certificates to health practitioners in order to ensure only qualified and competent health practitioners.
- Oversees effectively the licensing of health facilities and accreditation of health care services in order to assure the provision of quality health services to the public
- Oversees effectively the approval and recognition of health training programmes in order to ensure compliance to set standards.
- Provides effectively Secretariat services to the Council and its Committees in order to facilitate the smooth conduct of business.
- Oversees effectively the development and implementation of risk management policy and framework in order to mitigate risks
- Oversees effectively, the monitoring and evaluation of Programmes in order to facilitate implementation of appropriate interventions
- Ensures timely provision of human resources, administrative, financial and other support services in order to facilitate efficient and effective operations of the Council.
- Ensures effectively the implementation of performance management systems in order to improve individual and organisational performance and productivity
